

The Terms and Conditions of your appointment are as follows;


- 1) You will be on probation for period of two years from the date of your joining. During the period of probation, your services can be discontinued by the management if your services are not found satisfactory by giving you one month's notice. You can also discontinue by giving one month's notice or one month's pay in lieu of the notice period.
- 2) You are appointed in the pay scale of Rs. 37400-67000 with starting basic pay of Rs. 37400/- + AGP of Rs. 9000/- per month in the time scale. After successful completion of one year out of your probation period, normally you will be entitled to annual increment subject to your satisfactory performance and conduct and a report thereof from the concerned Head of the Department. is obligatory on your part to carry out any other responsibilities assigned by the University and college from time to time.

- 10) You are also required to undertake the responsibilities in the College / Hospital and any other medical activities which are conducted by the College in relation to the patient care, student care and that of academic nature, related to professional pursuits, and also take part in Administrative task related to College and Hospital and shall have to strive to maintain dignity and standard of the college and Institute.
- 11) You will have to undergo a Medical Examination from the Medical Board of Kasturba Hospital constituted by the Institute.
- 12) The Management can also seek your Antecedent Character Report from the police authority.
